Subject: De-selection of RTPs selected for Audit as per section 65 of the WBGST Act, 2017 for the period starting on or after 1st day of April, 2021 and ending on or before 31st day of March, 2022 or part thereof and for the period starting on or after 1st day of April, 2022 and ending on or before 31st day of March, 2023 or part thereof.

WHEREAS, The Commissioner, State Tax, West Bengal selected nine hundred and ten (910) number of registered persons for conducting audit under section 65 of the West Bengal Goods and Services Act, 2017 (hereinafter referred to as the said Act) for the period starting on or after the 1st day of April, 2021 and ending on or before the 31st day of March, 2022 or part thereof and for the period starting on or after 1st day of April, 2022 and ending on or before 31st day of March, 2023 or part thereof (hereinafter referred to as the said periods) upon issuing order bearing numbers 3370 CT, dated 28.05.2024, 500 CT, dated 22.01.2025 and 501 CT, dated 22.01.2025 read with order bearing numbers 5575 CT, dated 29.08.2024, 6069 CT dated 17.09.2024 and 499 CT dated 22.01.2025;
