Subject: Deselection of RTPs selected for Audit as per section 65 of the WBGST Act, 2017 for the periods starting on or after 1st day of April, 2020 and ending on or before 31st day of March, 2021 and on or after 1st day of April, 2021 and ending on or before 31st day of March, 2022 or part thereof.

WHEREAS, The Commissioner, State Tax, West Bengal selected a number of registered persons for conducting audit under section 65 of the West Bengal Goods and Services Act, 2017 (hereinafter referred to as the said Act) for the periods starting on or after 1st day of April, 2020 and ending on or before 31st day of March, 2021 and on or after 1st day of April, 2021 and ending on or before 31st day of March, 2022 or part thereof (hereinafter referred to as the said period);

AND WHEREAS, orders bearing numbers 3370 CT, dated 28.05.2024 and 3684 CT dated 12.06.2024 were issued by the Commissioner, State Tax, West Bengal with respect to such selection, under sub-section (1) of section 65 of the said Act;

AND WHEREAS, I am satisfied that Audit of six (06) registered persons under different jurisdictions, specified in the list annexed, is not required for the said period due to reasons specified in the list annexed;

NOW THEREFORE, I hereby deselect such six (06) registered persons, specified in the list annexed, from Audit under section 65 of the said Act for the said periods.
