Tender is to be submitted along with relevant documents including copies of Trade License, Income Tax PAN No. IT returns for the last three years, Profession Tax Payment Certificate, Voter card, Aadhar Card etc.

Besides day light hours, services shall be made available at any time as may be called for and the labour shall be made available to perform the duties as called for at any place within the jurisdiction of Kharagpur Range. All liabilities w.r.t. labour laws and other statutes shall have to be complied with and shall be the sole liabilities and responsibilities of the tenderers. The office shall have no liabilities w.r.t. the safety security of life or property of the labourers so provided.

Bids are invited in two parts –(1) Technical Bid consisting of all technical details along with commercial terms and conditions; (2) Financial Bid indicating consolidated charges including statutory taxes and liabilities present and future for services mentioned in the tender. Both bids should be sealed in separate cover duly superscribed and are to be put in a bigger cover which should also be sealed and duly superscribed. After evaluation the lowest rate financial bid from among technically qualified bidders shall be accepted. If the number of tenderers /bidders qualified in technical bid is less than three, tender will be invited afresh. The terms of the tender may when required be negotiated at the time of opening of the tender in the presence of the best/lowest bidder.

Tender is to be submitted along with self attested copies of Trade License, Income Tax Pan No. and IT returns for last three years, receipted challans showing upto date payment of Profession Tax, Aadhaar Card, Voter Card and Labour contractor's Registration Certificate [if applicable] and photo identity proof to this office between from 4th June, 2018 at 11 a.m. to 12 noon of 12th June, 2018 at 11am. to 12 noon. Tenders will be opened at 02:00 pm on 12th June, 2018. Technical Bids followed by Financial Bids.

Last date and time for submission: : 12th, June 2018, 12 :00 noon.

Tender will open : 12th June, 2018 at 1.00 p.m.

Interested persons may participate in the opening of tenders at the designated date, time in the office of the undersigned.
