NOTICE FOR AUCTION OF GOODS UNDER THE GST ACT, 2017  
Auction No.: DCT/WB/CB/2026-27/01

A closed-bid auction of seized/confiscated goods under the GST Act, 2017 will be held on 09.06.2026 at 11 AM. at the Directorate of Commercial Taxes, 14, Beliaghata Road, Kolkata – 700015. Intending bidders having GST registration numbers will have to submit their bids for the goods listed herewith.

To participate in the auction and to obtain an entry pass for inspection of goods, intending bidders must make a pre-bid deposit of Rs. 25,000/- (refundable in case of unsuccessful bidders) through a Demand Draft drawn in favour of the “*Commissioner, Commercial Taxes, Government of West Bengal*”.

Successful bidders will have to make payment of the full bid amount within fifteen days from the date of the auction and lift the goods within seven working days thereafter, upon showing proof of payment. Otherwise, their bid will be automatically cancelled and the pre-bid deposit will be forfeited.

Goods for auction will be open for inspection on 02.06.2026 from 1.00 PM to 4.00 PM at the following premise:

(i) 1/1A Nawabputty Street, Cossipore, P.S.– Chitpur, Kolkata–700002.

Entry passes for inspection of goods will be issued from Room No. 702, 7th Floor, Annex Building-II, 14, Beliaghata Road, Kolkata – 700015 on 28.05.2026 and 29.05.2026 from 11.00 AM to 4.00 PM. No person will be allowed to inspect goods without an entry pass.

Intending bidders will have to submit their bid value (as per the attached format) in a sealed envelope and drop the same in the Drop Box in Room No. 205, 2nd Floor, 1st Building, 14, Beliaghata Road, Kolkata – 700015 on 04.06.2026 and 05.06.2026 from 11.00 AM to 3.00 PM.

The Drop Box and financial bids will be opened on 09.06.2026 at 11:00 AM in the presence of the Special Commissioner of Revenue, Additional Commissioner of Revenue, members of the Auction Committee, and participating bidders.

**Collection of Entry Pass:**

Visit Room No. 702, 7th Floor, 2nd Building, 14, Beliaghata Road, Kolkata – 700015 on 28.05.2026 and 29.05.2026 from 11 AM to 4 PM to collect the entry pass for inspection of goods.

Participants are required to furnish the following documents at the time of issue of the entry pass:

1. Proof of identity (Voter ID Card / Aadhaar Card / PAN Card)
2. Address proof (Driving Licence / Electricity Bill / Telephone Bill / Voter ID Card / Aadhaar Card)
3. Copy of GST Registration Certificate under the GST Act, 2017

Demand Draft of Rs. 25,000/- (refundable in case of unsuccessful bidders) drawn in favour of the “*Commissioner, Commercial Taxes, Government of West Bengal*”.

4. Each participant must strictly follow the terms and conditions laid down hereinbefore, and no conditional offer will be accepted.
