NOTICE FOR AUCTION OF OLD, USED AND DISCARDED FURNITURE (MADE OF IRON AND TIMBER) ALONG WITH OTHER GOODS.

Interested bidders will have to submit demand draft (refundable) amounting to Rs. 25,000/- in favour of the Commissioner of Commercial Taxes, Government of West Bengal. Eligible bidders will have to make payment of 25% of their bid values by cash on the date of auction and the remaining amount to be paid within seven (07) days from the date of auction and to lift goods within seven (07) working days thereafter showing proof of payment. Otherwise their bids will automatically be cancelled and the deposited amount will be forfeited. Goods for auction will be opened for inspection on 16th September, 2019 from 01-00 p.m. to 04-00 p.m. at this Directorate. Entry pass for participation in auction will be issued from 2nd Bldg., 8th floor, Room no. 802 of this Directorate on 19.09.2019 & 20.09.2019 from 01-00p.m. to 04-00 p.m. on submission of the demand draft mentioned above. No person will be allowed to participate in auction without an entry pass.
