Quotations are invited in sealed cover for the supply of 1(one) Light Commercial Vehicle with 2(two) Labourers during the period from August 2014 to March,2015 for lifting of goods seized by the mobile duty teams of the Commercial Tax Directorate from any place in and around Kolkata to the Sales Tax Building at 14, Beliaghata Road or the godown at 5, Canal West Road, Kolkata-15. Quotations, stating rate per month, can be dropped in the box kept in the chamber of the Senior Joint Commissioner, Sales Tax, Central Section (Preventive) 7<sup>th</sup> floor, Room No. 713, 14, Beliaghata Road, Kolkata-700015 or reach his Office on or before 21st July, 2014 up to 3:00 PM and those shall be opened on that day in the presence of the quotationers or their authorized representatives who wish to be present

## **TERMS AND CONDITIONS**

- 1) The owners of Light Commercial Vehicle with valid Registrtion, road permit, Pollution Control and Insurance Certificate can apply. 2(two) labourers for loading and unloading of goods in/from the vehicle will be required to be supplied by the vehicle owner along with the vehicle.
- 2) The vehicle will be used in the Central Section( preventive wing) during the period 8-00 A.M. to 8-00 P.M. on all days including Sundays and holidays for lifting of seized goods from any place, normally in and around Kolkata to the Sales tax Office at 14, Beliaghata Road, Kolkata-700015 as and when required. However, in case of urgency/ emergency, the vehicle can be deployed beyond normal duty hours.
- 3) The fuel will be supplied by the owner of the vehicle.
- 4) The owner of the vehicle should be in a position to replace it with another vehicle in the event of mechanical failure or repairing of the former.
- 5) The vehicle should always be kept in good condition with sufficient fuel in the tank.
- 6) The charges of hiring of the vehicle along with 2(two) labourers should be billed at monthly rate. The monthly hiring bill should be submitted by 10<sup>th</sup> day of the next month on a regular basis.
- 7) The owner of the vehicles shall produce evidence in respect of enrolment of Profession Tax, PAN and EPIC issued by the Election Commission of India.
