**NOTICE FOR AUCTION OF OLD ACCUMULATED SCRAPS.**

Successful bidder will have to make payment of 25% of his bid value by cash on the date of auction and remaining amount to be paid within seven (07) days from the date of auction and lift goods within seven (07) working days thereafter showing proof of payment. Otherwise his bid will be automatically be cancelled and the deposited amount will be forfeited.
