NOTIFICATION

No. 1090-F.T.– the 2nd day of July, 2012.— In exercise of the power conferred by sub-section (1) of section 22 of the West Bengal Tax on Entry of Goods into Local Area Act, 2012 (West Ben. Act I of 2012), the Governor is pleased hereby to make the following amendment in the West Bengal Tax on Entry of Goods into Local Area Rules, 2012, published *vide* notification in the *Kolkata Gazette*. *Extraordinary*, Part-I, dated the 31st March, 2012 (hereinafter referred to as the said rules):—

Amendment

In the said rules, in Chapter-II, after rule 6, insert the following rule:—

"6A. Deduction from turnover of imports for import of newsprint.— Where a manufacturer or printer as the case may be, of newspaper organisation registered with the Registrar of Newspapers of India imports newsprint into a local area in West Bengal for the purpose of printing in West Bengal of newspaper only, no tax shall be levied under this Act and accordingly the import value of the newsprint shall not be included in turnover of imports under clause (c) of sub-section (4) of section 4, subject to furnishing of a declaration appended to this rule duly filled in and signed by such manufacturer or printer, as the case may be, of the said newspaper organisation:—
