**NOTIFICATION**

No. 285-F.T.- 12.03.2013.— In exercise of the power conferred by sub-section (1) of section 3, *read* with sub-section (1) of section 7, of the West Bengal Sales Tax Act, 1994 (West Ben. Act XLIX of 1994), as subsequently amended (hereinafter referred to as the said Act) and in partial modification of earlier notification issued on the subject-matter, the Governor is pleased hereby to notify that—

- (1) the Bureau of Investigation constituted under sub-section (1) of section 7, *read* with clause (e) of section 107, of the said Act, shall discharge its function through the following Units, namely:—
  - (a) Bureau of Investigation (Unit 1), having different Zones as may be considered necessary by the Commissioner for discharging the functions under the afore-said Acts to investigate transactions of dealers under Corporate Division, Kolkata (South) Circle, Chowringhee Circle, Dharmatala Circle, Burrabazar Circle and Behala Circle;
  - (b) Bureau of Investigation (Unit 2), having different Zones as may be considered necessary by the Commissioner for discharging the functions under the afore-said Acts to investigate transactions of dealers under Howrah Circle, Bally Circle, Asansol Circle, Durgapur Circle and Midnapore Circle; and
  - (c) Bureau of Investigation (Unit 3), having different Zones as may be considered necessary by the Commissioner for discharging the functions under the afore-said Acts to investigate transactions of dealers under Kolkata (North) Circle, 24-Parganas Circle, Berhampore Circle, Siliguri Circle, Jalpaiguri Circle and Raiganj Circle;
- (2) the persons posted in different Zones under the different Units of Bureau of Investigation may exercise jurisdiction throughout the whole of West Bengal for discharging their functions as may be required for

investigation involving transactions of dealers assigned to the different Units as mentioned in sub-paragraph (1), and any person or transporter and for movement of goods into, within, or through, the State by any person or transporter;

- (3) the investigations previously undertaken by the Bureau of Investigation and other works including relating to cases of investigation already made before the date of coming into force of this notification shall be dealt with by the Bureau of Investigation (Unit 1) as mentioned in clause (a) of sub-paragraph (1).

2. This notification shall come into force with effect from the 12th day of March, 2013.
